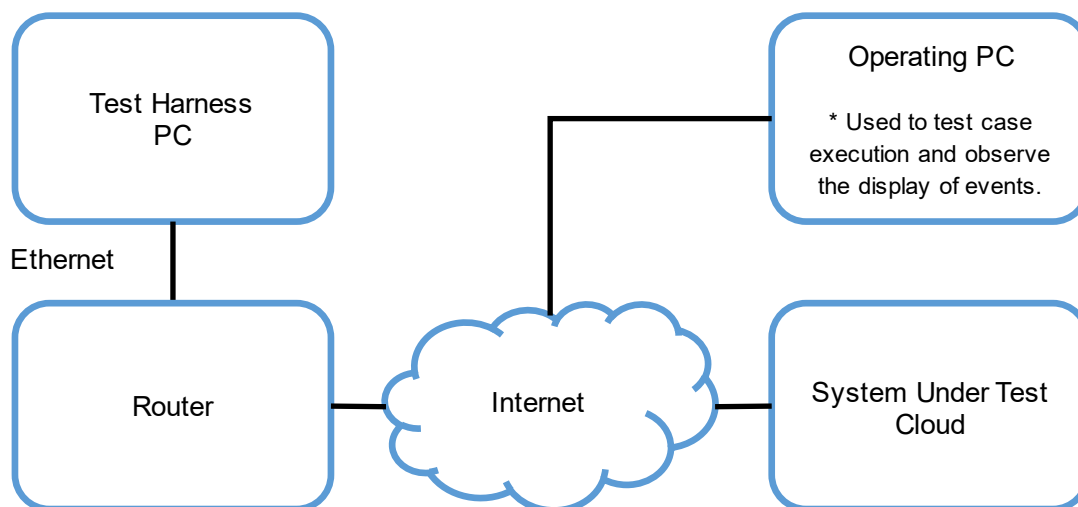

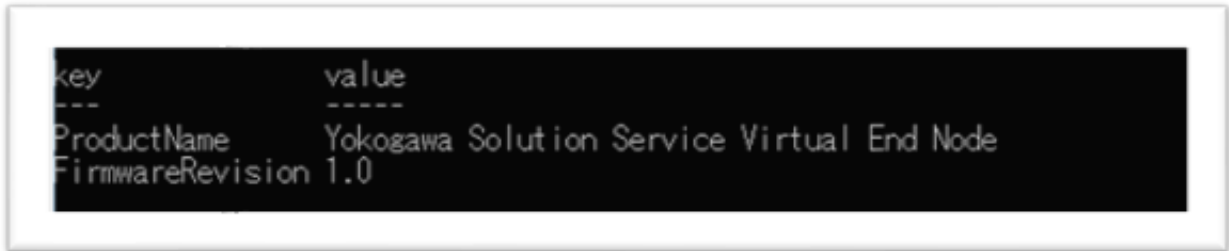


Photo 1: System screen capture (Product Information, Firmware Information)
